

भारत गुरदासपुर हमले से जुड़े सबूत देगा पाक को

नई दिल्ली, 3 अगस्त (भाषा)। भारत इस महीने के आखिर में राष्ट्रीय सुरक्षा सलाहकार स्तर की प्रस्तावित बैठक के दौरान पाकिस्तान को इस बात के सबूत सौंपेगा कि गुरदासपुर पर हमला करने वाले आतंकी सीमा पार से आए थे।

घटनाक्रम से जुड़े सूत्रों ने बताया कि भारतीय पक्ष 1993 के मुंबई बम विस्फोट मामले के मास्टरमाइंड और अंडरवर्ल्ड डॉन दाउद इब्राहीम से जुड़े आतंकी मामले भी पाकिस्तान के समक्ष उठा सकता है। सूत्रों ने कहा- 'सब कुछ उनके सामने होगा।' उन्होंने कहा- गुरदासपुर आतंकी हमले से जुड़े मामले में एंजिसियां सबूत जुटा रही हैं। मारे गए तीन आतंकीयों के जूतों में लगी मिट्टी के नमूने जांच के लिए भेजे जा चुके हैं। सूत्रों ने बताया कि गुरदासपुर आतंकी हमले से जुड़े सबूत अभी जुटाए जा रहे हैं।

एंजिसियां इस बात के पक्के सबूत जुटा रही हैं कि ये आतंकी हमला सीमा पार से रची गई साजिश का नतीजा था, जिसमें एक पुलिस अधीक्षक सहित कुछ सात लोग मारे गए थे।

सूत्रों ने बताया कि बातचीत के दौरान भारत मुंबई में 2008 के आतंकी हमले के मास्टरमाइंड लश्कर ए तैयबा के कमांडर जकी उर रहमान लखवी से जुड़े मामले का दस्तावेज तैयार कर पाकिस्तान को सौंपेगा। उन्होंने बताया कि आतंकी हाफिज सईद से जुड़े सबूत भी पाकिस्तान को सौंपे जाएंगे। सीमा पार आतंकवाद से जुड़े मामलों के तमाम साक्ष्य पाकिस्तानी पक्ष के सामने रखे जाएंगे।
