- New Independent Directors are provided with copy of latest Annual Report, BBL Code of Conduct, BBL Code of Conduct for Prevention of Insider Trading.
- The Company provides the Directors with the visit of company's factory unit from time to time.
- A detailed Appointment Letter incorporating the role, duties and responsibilities, remuneration, etc. is issued for the acceptance of the Independent Directors.

> OTHER INITIATIVES TO UPDATE THE DIRECTORS ON A CONTINUING BASIS

- The Directors get an opportunity to visit Company's plant, where plant heads appraise them of the operational aspects of the plant to enable them to have full understanding on the activities of the Company and initiatives taken on safety, quality, etc.
- At various Board meetings during the year, presentations are made to the Board on safety, health and
 environment and sustainability issue, risk management, company policies, changes in the regulatory
 environment applicable to the corporate sector and to the industry in which it operates, with areas of
 improvement and other relevant issue.

• Quarterly presentations on operations made to the Board include information on business performance, operations, market share, financial parameters, compliances and other regulatory scenario etc.
